## TENTATIVE AGENDA **TELEPHONIC MEETING** November 29, 2018 at 2PM State Capitol Building, Room 102 1007 E. Grand Avenue, Des Moines IA

### **I. CALL TO ORDER**

Chair Albert calls meeting to order at 2:00 pm. Tillotson, Roos, Rueter and Olson appear by telephone. Albert appears in person. Due to brevity of meeting, Albert states it would be impracticable for Board to meet in person.

### **II. APPROVAL OF MINUTES**

Motion by Rueter, second by Olson, to approve minutes of meeting held on November 15, 2018. All ayes. Motion carries.

### **III. LEGISLATIVE PROPOSALS**

#### **1. Amend section 68A.505**

Motion by Olson, second by Tillotson, to propose amendment to section 68A.505. Roos asks Tooker if her intention is for the Board to propose either an amendment to section 68A.505 or a new section 68A.505A or both. Tooker says the Board could propose both or one of them. Roos says he proposes adding to the list of public resources in section 68A.505A, "office, work room or production area of any building owned or leased by a government entity." Discussion followed. General consensus is that addition would make it less likely to get a proposed section 68A.505A successfully through the legislature. Roos withdraws his proposal. Olson and Tillotson agree to withdraw their motion.

#### **2. New section 68A.505A (prohibiting the use of certain government resources for political purposes)**

Motion by Olson, second by Tillotson, to propose a new section 68A.505A and not propose any amendments to section 68A.505. All ayes. Motion carries.

#### **3. New section 68A.302A (allowing campaign funds to be used for dependent care)**

Olson says she requested Tooker draft a bill allowing campaign funds to be used for dependent care because it would enable more people to run for office. Motion by Olson, second by Rueter, to propose a new section 68A.302A. All ayes. Motion carries.

### **IV. ADJOURNMENT**

Motion by Rueter, second by Roos to adjourn meeting. All ayes. Motion carries. Meeting adjourns at 2:38 pm.
